difference between administrator and receiver is that administrator is one who administers affairs one who directs manages executes or dispenses whether in civil judicial political or ecclesiastical affairs a manager while receiver is web mar 11 2021 there are some key differences between receivership administration and liquidation to keep in mind role of appointee receivers administrators and liquidators all have different responsibilities for example key responsibility of the receiver is to recover debt for secured creditors web administration s primary goal is to help the company pay off their debts thus avoiding entering liquidation at least in the first instance receivership works to realise the assets of a company to maximise the benefit for the secured creditors web receiver a receiver is a person empowered to control a particular asset by virtue of a court order charge finance agreement or provision of the law the receiver can secure sell or manage the asset the asset may include the entire company which it web a receiver is a profession intended for a bachelor of law and a bachelor of accounting not only receiver but in some cases there is also an administrator that focuses on postponing debt repayment obligations there are two types of receivers and administrators the first type is balai harta peninggalan web an administrative receiver refers to a person appointed by a court to administer the affairs of a company s he takes control of all or
